Vaccinations Required:

Proof that all vaccinations are current is required before your dog's first class. What we need to see on the records is date given/ date due for each of the following core vaccinations:

- Rabies
- Bordatella (kennel cough)
(available as both subcutaneous injection and intranasal spray covering just Bordatella, or Bordatella/ Parainfluenza)
- Distemper - various combinations include:

DHPP (Distemper/ Hepatitis/ Parvovirus/ Parainfluenza)
DAPP (Distemper/ Adenovirus / Parvovirus/ Parainfluenza)
DHLPP (Distemper/ Hepatitis/ Leptospirosis/ Parvovirus/ Parainfluenza)
DA2PPC (Distemper/ Adenovirus-2/ Parvovirus/ Parainfluenza/ Coronavirus)
DA2PPV (Distemper/ Adenovirus-2/ Parvovirus/ Parainfluenza)
DA2PPL (Distemper/ Adenovirus-2/ Parvovirus/ Parainfluenza/ Leptospirosis)
DHL4P (Distemper/ Hepatitis/ 4 variations of Leptospirosis/ Parvovirus)

For the health of your dog, please talk to your Vet about the benefits and potential side effects of all vaccines. At Happy Hounds we take great pride in our efforts to provide a clean and safe environment for your dogs, but just like children at any school or daycare, bugs will be passed around from time to time. We encourage you to do your own research on the most common diseases that could potentially affect your dog when involved in group training classes. Dog Training Services Agreement

This Agreement between _____ (hereinafter referred to as "Client") and Olivia C. Neill acting as agent for Happy Hounds, LLC (hereinafter known as "Trainer") pertains to the following:

Client's Dog (Name): _____ Breed: _____ Age: _____ Color: _____ (hereinafter referred to as "Dog")

For good and valuable consideration, the parties agree as follows:

Training Fees:

Client agrees to pay Trainer a nonrefundable fee in the amount of \$_____. This fee includes _____, one-hour (semi-private) group training classes.

Services: Trainer agrees to provide group lessons for Client and Dog, the goal being to teach Client how to train and work with Dog. Trainer will make every reasonable effort to help Client achieve training and behavior modification goals but makes no guarantee of Dog's performance or behavior as a result of providing professional animal behavior consultation.

Cancellation Policy: If Client fails to give at least 24 hours cancellation notice, or is not present at time of a scheduled class, they cannot make up that lesson. The option to purchase a make-up session would be available for \$25 per lesson.

Liability: If Dog causes property damage, or bites or injures any dog, animal or person (including but not limited to Trainer and Trainer's agents), during or after the term of this Agreement, then Client agrees to pay all resulting losses and damages suffered or incurred, and to defend and indemnify Trainer and Trainer's agents from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees.

At Trainer's sole election, Trainer's duties hereunder shall terminate if (a) in Trainer's sole judgment Dog is dangerous or vicious to Trainer or any other person or animal (b) Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, Trainer's duties shall terminate but all other provisions of this Agreement shall continue in full force and effect.

This Agreement is binding upon Client, spouse of Client, and children of Client. This Agreement supersedes all prior discussions, representations, warranties and agreements of the parties, and expresses the entire agreement between Client and Trainer regarding the matters described above. The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations or oral understandings have been made with regard to Dog or anything else. Without limiting the generality of the foregoing, Client acknowledges that Trainer has not represented, promised, guaranteed or warranted that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioral problems, or that the results of the training will last for any particular amount of time. This Agreement may be amended only by a written instrument signed by both Client and Trainer.
