Vaccinations:

Proof that all vaccinations are current is required before your dog's first play day. What we need to see on the records is date given/ date due for each of the following core vaccinations:

- Rabies
- Bordatella (kennel cough)
(available as both subcutaneous injection and intranasal spray covering just Bordatella, or Bordatella/ Parainfluenza)

- Distemper

various combinations include:

DHPP (Distemper/ Hepatitis/ Parvovirus/ Parainfluenza)
DAPP (Distemper/ Adenovirus / Parvovirus/ Parainfluenza)
DHLPP (Distemper/ Hepatitis/ Leptospirosis/ Parvovirus/ Parainfluenza)
DA2PPC (Distemper/ Adenovirus-2/ Parvovirus/ Parainfluenza/ Coronavirus)
DA2PPV (Distemper/ Adenovirus-2/ Parvovirus/ Parainfluenza)
DA2PPL (Distemper/ Adenovirus-2/ Parvovirus/ Parainfluenza/ Leptospirosis)
DHL4P (Distemper/ Hepatitis/ 4 variations of Leptospirosis/ Parvovirus)

For the health of your dog, please talk to your Vet about the benefits and potential side effects of all vaccines. At Happy Hounds we take great pride in our efforts to provide a clean and safe environment for your dogs, but just like children at any school or daycare, bugs will be passed around from time to time. We encourage you to do your own research on the most common diseases that could potentially affect your dog when involved in group play. We also ask that you provide us with updated copies of your pup's shot records as you get them. This allows us to keep the most recent data in our system and means the automated vaccination 'reminder' emails you will receive from us will actually be useful! Boarding (optional): Beds, blankets, treats, bowls, toys, crate(s), articles of clothing from home (for that 'Mom & Dad smell').

CLIENT AGREEMENT AND WAIVER OF LIABILITY

By signing and initialing below, I understand and agree to the following terms and conditions:

_____ 1) **Health and Behavior of Pet:** I agree and understand that Happy Hounds has relied upon my representation my dog is in good health, has not injured or shown threatening behavior to any persons or animals, and is current on all required vaccines and flea treatments (DHPPC, Rabies, and Bordetella).

_____ 2) **Risks to Pet:** I agree and understand that Happy Hounds will not be liable for any injury to my pet that is inherent to dog daycare and boarding environments; including, but not limited to injuries or illness resulting from commingling, fights, rough play, contagious diseases, separation anxiety, indoor/outdoor activities, tethering, lack of proper grooming, crating, and dramatic change in diet. I give consent for my dog(s) to be commingled.

_____ 3) **Behavioral Corrections:** I agree and understand that should my pet demonstrate behavior that is aggressive or threatening to the other dogs or staff, Happy Hounds may use its discretion to immediately correct that behavior, including, but not limited to placing my pet in the crate for “time outs”, using squirt water bottles, citronella spray, and any other necessary techniques. Happy Hounds reserves the right to dismiss my pet from their programs and boarding if my pet exhibits dangerous behavior, and I will arrange pick up from the facility within 3 hours of being notified about such a dismissal.

_____ 4) **Damage to Facility:** I agree and understand, as the owner of my pet, that I will be financially responsible for any damage to the facility caused by my pet.

_____ 5) **Administering Aid:** I agree and understand that should my pet become ill or appear in need of medical attention, Happy Hounds shall have full discretion in administering treatment and I will pay any and all expenses involved in obtaining the necessary treatment, including, but not limited to, veterinarian visits, medications, examinations and surgery. Happy Hounds agrees to make reasonable efforts to contact me should aid be necessary, however, if they are unable to reach me or need to administer aid immediately, Happy Hounds may use their discretion and administer aid without contacting me first.

_____ 6) **Abandonment:** I agree and understand that I must be timely in picking up my pet from the facility, and a failure to comply with the arranged pick up time can result in being charged an additional days stay. Also, if my pet is left at Happy Hounds for a period exceeding five days from the arranged pick up date without contact from me, the dog will be considered abandoned and Happy Hounds will have discretion to the disposition of my pet, pursuant to Colorado Revised Statutes Code 35-80-102.

_____ 7) **Release of Liability:** I agree, understand and hereby release Happy Hounds, their owners, staff, partners and volunteers, financially or otherwise, for injuries to my pet, myself, or any property of mine while my pet is participating in services provided by Happy Hounds.
